___ I understand that Animal Rescue Center of Shawnee animals come from varied backgrounds, and that Animal Rescue Center of Shawnee makes no warranty as to pedigree, breed, disposition, history, or health of this animal.

___ I have been advised to have this animal examined within 7 days of this adoption by my veterinarian, at my own expense, or by a veterinarian who donates services to Animal Rescue Center of Shawnee. A list has been provided to me.

___ If the veterinarian deems the animal is ill with a pre-existing condition within 72 hours of adoption I must contact Animal Rescue Center of Shawnee immediately, before any treatment is done. Otherwise Animal Rescue Center of Shawnee WILL NOT be responsible for any medical expenses incurred.

___ I agree that I will not allow this animal to run at large, to become a nuisance, or to violate any applicable laws, ordinances, or regulations.

___ I understand that as the adopter of this animal this pet will reside with me at my residence listed above.

___ I agree that I will provide this animal with proper food, water, shelter, vaccinations and proper veterinary care, and that I will obtain all applicable licenses or permits.

___ I agree to allow Animal Rescue Center of Shawnee to inspect the animal's living conditions at any time. I agree that if Animal Rescue Center of Shawnee finds the conditions to be unsatisfactory I will either rectify the problem(s) immediately, or I will relinquish the animal to Animal Rescue Center of Shawnee. I agree that in cases of abuse or neglect removal of the animal will be immediate.

___ If this animal is a dog I agree that I will not keep the dog tethered/chained.

___ If the animal is a dog, and does or is likely to weigh more than 20 pounds, I agree that I have an adequately sized/fenced yard for proper exercise or that I have a plan to provide the pet the exercise required to keep it healthy.

___ If at any time I am unable or unwilling to keep the animal, I will contact Animal Rescue Center of Shawnee first before rehoming the animal. I understand that I cannot abandon this animal under any circumstances.

___ If I fail to comply with any of the terms of this contract, I agree that Animal Rescue Center of Shawnee has the right to repossess this animal, and that I will forfeit all adoption and licensing fees I tendered to Animal Rescue Center of Shawnee. I also agree to pay any and all legal fees Animal Rescue Center of Shawnee incurs in that action.

I UNDERSTAND THAT THIS IS A BINDING LEGAL CONTRACT. I CERTIFY THAT I HAVE READ IT CAREFULLY, THAT I UNDERSTAND ITS TERMS, AND THAT THIS CONTRACT EXPRESSES MY ENTIRE AGREEMENT WITH ANIMAL RESCUE CENTER OF SHAWNEE.
